NOAH'S JOURNEY By Noah's Mom, Cynthia

I woke up in a cold sweat. Something was wrong. The nurse had taken Noah to the nursery at the change of shift. It was three hours later. Why hadn't they brought him back? My husband Keith said, and I agreed, that they probably saw we were asleep and kept him in the nursery. I tried not to think about it. Not two minutes later, the

pediatrician and a nurse walked into my hospital room. Noah had had his first seizure. He was two days old and we were due to be discharged the next morning. Needless to say, I went home and Noah stayed in the hospital for eight more days.

We thought, in the beginning, as did the medical staff involved with Noah, that his seizures were benign. We were told nothing was found of any importance and that Noah would 'outgrow' the seizures. That did not turn out to be the case. At five months old, Noah was diagnosed with "Infantile Spasms." This is the name for a type of seizure disorder that meant chaos was occurring in Noah's brain. Some of the treatments we tried were horrible for Noah and us. He would cry 24 hours a day. The only comfort came from rocking him in the Lazy Boy chair. We LIVED in that Lazy Boy for months. Nothing is worse than seeing your child seize and cry continuously like something was hurting him. No parent is ever prepared for the turmoil and stress of seeing their child suffer.

Much of Noah's life has been in and out of the hospitals. At age four, his seizure disorder transitioned into Lennox Gastaut Syndrome or LGS, which means multiple seizure types with resistance to medications. He has also added several other diagnoses along the way. He had to have surgery on his back and hip due to his cerebral palsy. He had a surgery to implant a vagal nerve stimulator to help with seizures. He has also had multiple pneumonias and other respiratory illnesses.

Our biggest goal, as Noah's parents, has been to give him every experience we could



give him. No one in the medical field has ever been able to tell us why Noah is the way he is. Noah is 11 years old now and, I must say, it's not really important to us anymore. He is the way he is and it is our job to make sure he experiences everything in life just like any other child.

Noah has been non-verbal for much of his life; however, there is no denying the excitement on his face when he's

doing something he enjoys. He has also just begun working with a communication device. This is a special computer programmed so that Noah can share everything from how he's feeling to what movie he wants to watch to what he wants to do. Noah has always loved swimming, baseball games, music, movies, and Disney World. Make a Wish sent Noah to Disney World in 2007. That trip could never be duplicated. He had a blast and we added memories to all of our lives. That has been our motto throughout Noah's life, to "Make memories."

How have we been able to do things with Noah when you think about everything involved in his care? It was easy, and still is at times, to become wound up in the monotony of responsibilities that include doctor's appointments, therapy appointments, IEP meetings at school, insurance claims and hearings. We could never accomplish even the daily routine without our circle of support. Our family, friends, nursing agency, church, and Edmarc allow us the opportunity to stay afloat.

We have been with Edmarc for about four and a half years, I think. We were connected to Edmarc through a friend whose son also receives services. The nurses, social workers, volunteers, and everyone else at Edmarc have been responsible for helping us make more memories with Noah. We have been able to shorten hospital stays, or prevent them all together, by having the nurses from Edmarc assist us with Noah's care. They take some of the stress away from

Back to school time

Area schools are in full operation as we speak, and our Edmarc kids are still in need of supplies. Many of our families have a difficult time affording school supplies, and we count on donations to assist them. The items required vary, but most of the kids need the following: book bags, lunch boxes, pencil boxes, pencils, pens, highlighters, erasers, crayons, markers, rulers, scissors, notebooks and paper, folders and binders and arts and crafts supplies. Many of our older children need scientific calculators for math.

Because the supplies each child needs vary so much from school to school, and across grade levels, one of the best ways to contribute is to purchase gift cards specifically for school supplies. Many donors are reluctant to do this; however, there are many times we may not have specifically what a teacher has asked for in the office. Gift cards are immensely helpful as solutions to that problem.

Listed below you will find a guide for locations where gift cards may be purchased, and how much various amounts may provide for a student in need. Book bags and lunch bags are always needed, but often it's the younger kids people have in mind. Frequently, we do not get enough school items for our older children, the teens. They have their lists, too! Also, many of our families very often need help with the purchase of school clothes as well as with the purchase of supplies; gift cards for any local department store, in increments of \$25-\$100 for clothing, are also very welcome. Yorktown Rotary weekend


A fine fish tail from the Yorktown Rotary Weekend
