LOVE AND FAITH WIN OUT

~ By Kaiden's Mom

Kaiden was born on November 26, 2009, which also happened to be Thanksgiving Day. My little turkey baby came out completely healthy and almost 8 lbs.

Things were going great, until I happened to feel a tiny lump in Kaiden's nose. I took him to his pediatrician who assured me it was just a clogged tear duct and we had nothing to worry about. Kaiden was two months old at the time. We couldn't see the lump - just feel it. When we noticed that the lump had begun to grow, we called the doctor. He felt it might just be an infection and called in a prescription for an antibiotic.

We gave that a few days, but couldn't see any difference and the lump continued to grow. At this point we could see the lump bulging out and beginning to cut off the airway in his right nostril. We ended up going to the children's hospital where my little baby had to get a CT scan.

At the time the scan was the scariest thing to me. The results showed it was a tumor. The doctors wanted to do a biopsy to see if the growth was benign.

At this point it was a whirlwind going on in our minds. Kaiden had his biopsy done, and two days later we received a call telling us our son has Alveolar Rhabdomyosarcoma, a soft tissue cancer that normally affects teenagers but my now three- month old has it.

Kaiden started 42 weeks of chemotherapy, and did five and a half weeks of proton radiation. Through all this, he remained a happy baby, always with a smile on his face regardless of the harsh medicine going through his body. He finished his treatment a couple of months after his first birthday and we tried to get our lives back to normal.

Kaiden was scheduled to have scans every three months. Right before his six-month scans, I felt alongside his nose and found the smallest lump inside, The doctors said they didn't know how I found it, but Kaiden had relapsed.

He was given a five-percent chance of survival - words no parent ever wants to hear. We chose to



try an alternative treatment

because we didn't want to put our one-year-old through a year of harsh medications.

He did have surgery to remove the tumor and surrounding tissue, and was doing well. But about three months later, the tumor came back. The alternative treatment helped slow the growth but was no cure. He had to start another 46 weeks of chemotherapy.

Kaiden was still doing great and didn't let anything stop him; he took the year like the champ that he is. He was now three years old when this second round of chemotherapy was completed. The doctors were happy, but didn't like the scar tissue that remained where the tumor used to be. We felt the surgery they wanted to do was severe and chose to wait.

Two months later Kaiden relapsed again.

This made four tumors my poor baby had had in



we knew the surgery was necessary – the hardest decision of our lives.

In the summer of 2013, he underwent a seven- hour operation, removing half of his nose, part of his cheekbone and the surrounding tissue inside and out. Kaiden was in the most pain he had been in throughout his ordeal. For the first time he didn't just wake up and bounce right back pushing all the pain away. Six days later he had another surgery – six and a half hours - to start rebuilding his cheek.

But our Kaiden was back! He woke up in the PICU and said, "Can I go to the playroom?" Yes, he is that strong and amazing. Kaiden had a series of surgeries the whole summer to rebuild his nose and get everything to function. He celebrated his fourth birthday this past November and is as strong as ever. He recently had a seven-month scan and it showed NO EVIDENCE of cancer. He has never made it this far without a relapse.

He's looking forward to starting school this year, and finally being a normal kid, just with super powers! He still has to deal with small surgeries to work on the nose and other things that come with going though all he has gone through, but his story shows anything is possible with prayer and faith. God bless.




THANKSGIVING DELIVERED BY VOLUNTEERS FOR WHOM WE ARE SO VERY THANKFUL!

questions were explored and discussed in an atmosphere of support, sharing, acceptance and learning.

Edmarc's Bereavement Program strives to be present for children and adults throughout the Hampton Roads community to answer these tough questions; to help our school children, teachers, counselors and staff in making referrals; and to remind families that Peace by Piece offers camaraderie and sharing as an excellent grief support group for children and teens, ages five through 18. 
Edmarc Receives Video Grant from The Giving Library
