You are reading this because you are part of the EDMARC family. As such, you know the love and compassion associated with being in this family. You don't necessarily need to hear another story about how amazing EDMARC is and how the people within are some of the most compassionate and empathetic around. So, we wanted to provide a few thoughts to be shared with those families that recently learned or will learn that their child has been referred for hospice care.

You are likely terrified, confused, and uncertain, as we were in February 2015 when our sweet Ainsley was referred to hospice. You, like us, have preconceived ideas about what hospice care means and your friends and family are probably not sure of what this means for you and for your loved one's future. Well, prepare to be relieved and feel a sense of security, as all of your preconceived notions are proven to be myths. From the moment we met with Nurse

Theresa for the very first time, we felt instant relief to have EDMARC by our side for this next phase of Ainsley's journey.

As we endured our weekly and monthly check-ups, Madalyn, Abbey and the entire staff became like family to us. We looked forward to their visits, not just because of the medical care they provided, but more so for their love and affection, as they genuinely cared about Ainsley's well-being, and our family's well-being. Together, we enjoyed countless comforting visits and loads of smiles, hugs, and downright enjoyable company. EDMARC helped us gain confidence that we were making the best decisions for Ainsley.

Two months before Ainsley's passing in February, 2016, EDMARC brought Santa Claus to come visit her and our entire family. As we joined in lyrical glee, caroling together and as Santa sat closer to Ainsley, everyone was unified in the most uplifting of experiences. PENINSULA FRIENDRAISING BREAKFAST SPREADS THE WORD!

One of the greatest challenges Edmarc continues to face is bringing about wide ranging community awareness for Edmarc and its mission. Although we have had a number of physical locations over the years, Edmarc's services have been consistent and available to families throughout Hampton Roads since 1978.

From Franklin to the Southside to the Virginia Peninsula, our staff is available to families 24 hours a day, seven days a week, and 365 days a year. We look to our generous community to help us raise the necessary funds to provide these vital services.

It began nine years ago with an idea from our Peninsula Council, to host a Friendraising Breakfast. The plan was to invite individuals to a free breakfast, have an Edmarc family share their story, raise awareness about Edmarc's mission and the positive impact we have in Hampton Roads, and raise the funds needed to help us continue to serve our families in the best ways possible. The Peninsula Friendraising Breakfast was born.

This event has been highly successful as, time after time, it meets the goal to raise awareness of the need for Edmarc's specialized services. On average, the total number of children and families we serve live on the Peninsula ranges from 30-40% of our overall census. Although the breakfast is free to those who attend, there is still considerable cost involved. In view of this, two of our volunteers, Amy Thorstad and Mary Cowling, started brainstorming ideas as to the most effective way to raise the monies to cover that cost. Three years ago Amy and her friends and family put on a fundraiser in memory of her daughter, Taylor, who was under Edmarc's care during her courageous battle with a brain tumor. Taylor had an amazing sense of humor and lit up the room with her unforgettable laugh, so it was only fitting to celebrate her life by holding a fundraiser at a comedy club.

This year's event was held on February 16, 2017 when guests came together to show their support for Edmarc and the many children and their families the agency cares for. The Paradise Ocean Club, which provided an amazing sunrise over the Chesapeake Bay, offered the perfect location for the event. Baxter Simmons, Jr. and his crew prepared a scrumptious breakfast definitely fit for a king. There were 110 guests in attendance that included current and past families, board members, supporters, volunteers and staff. Longtime

supporter and Edmarc volunteer, Rob Cowling of Old Point National Bank, set the mood with background music while Bob Harper Photography captured memories of the morning. And it was our dear friend Pat Mallon of Indian Creek Productions who provided all the A/V equipment for the event.

None other than Hampton Roads own, Joe Flanagan of Joe's Job hosted the morning. He did a fabulous job keeping the morning flowing and sharing the history of Edmarc while interacting with guests in the audience. The highlight of the event was a presentation from Keith Murray, Tyler's dad. Keith is a physicist at NASA Langley. So, he started off by saying he's not used to speaking to crowds, he's mostly used to talking to peoples' shoes. That broke the ice, he and proceeded to share his family's journey.

It was shortly after Tyler's sixteenth birthday when he was diagnosed with cancer. During his treatment, the family was so afraid of compromising him that they barricaded themselves in their home. With the help of Edmarc's staff, the family was able to feel secure in providing Tyler with the tender loving care he needed to fight cancer in the sanctuary of their own home. The family came to know and love the Edmarc staff. He talked about the strength his family gained by having the staff available whenever needed. He described the nurses who visited in this way... "The nurses are like marshmallow dipped Navy Seals." Keith talked about miracles: "They don't always come when you want or expect them to, but when they do happen, it is beautiful, like notes on a musical staff, placed in a specific order, to create a masterpiece." Keith went on to describe what Edmarc's care meant to the family, "To us, Edmarc was one of those miracles, keeping us afloat when our world seemed to be falling apart in front of us." Keith's words were so powerful and heartfelt and touched everyone in the room. Tyler's story is one of victory; he was a happy discharge from Edmarc last year!

This is just one of the many stories that happen every day because of our generous community. And when all was said and done, the event raised nearly \$14,000 to support the good work of Edmarc. Perhaps the most important thing that happened was the event helped create friendships for the future.
