For Love of Karli By Karli's Mom

It was a miracle we both survived, really. I had a very normal pregnancy, but on this hot, summer day in late July, I started having severe pain in my lower abdomen. I was 35 weeks along. I was on my lunch break at work. I called the triage nurse, my mom and my mother-in-law for advice, but still felt like something was very wrong. Per hospital policy, I waited my turn. After I was back in a room for several hours with a nurse, she had difficulty finding the baby's heartbeat on the fetal monitor strip. Instead of calling someone, she had me drink more fluids and eat a snack. She still couldn't get a good heartbeat or movement. Finally, a doctor came in with an ultrasound machine.

A few minutes later, a second doctor was called in. Suddenly, I was being rushed off to the Operating Room. The doctor said, "Your baby is in serious trouble and we need to take her out right away by emergency C-section." My husband Scott, in the US Navy, was out at sea doing trials for an upcoming deployment. There was no time to call anyone; no family here. I suddenly felt very alone... and afraid.

When I woke up in the recovery room, my neighbor was at my bedside. How did she know? They said they would look in my cell phone contacts and call who needed to be called. I had no idea who they called or what those called were told. A Red Cross message was sent to my husband on the ship and he was able to call and talk to me briefly. They were flying him home the next morning.

Our daughter, Karli, was fighting for her life. She had a very low Apgar score. (The Apgar score is given to a newborn right after birth to quickly evaluate a newborn's physical condition and to determine any immediate need for extra medical or emergency care.) The Neonatal Intensive Care Unit (NICU) at this hospital did not have the knowledge needed to help her, so they would need to transport her immediately to a children's hospital. They let me see her before her transport. She was beautiful.

She was in the NICU for 30 days. My in-laws, my mom and my brother flew out to Virginia from Minnesota on her second day of life – because they were told by the birthing hospital staff that they needed to get here as soon as possible because mom and baby may not survive. They stayed for a week and my mom stayed on for two to help out. I was discharged after three days, even though my hemoglobin was only a seven.

On Karli's first day of life, upon admission at the children's hospital, she was placed on a hypothermia blanket (reduces the brain and body tempurature to 92.3 degrees to lessen the brain injury, caused by a hypoxic-ischemic encephalopathy (HIE) event or lack of oxygen, at birth). She had jaundice, kidney failure, liver failure. She had two exchange transfusions (where they took blood and placed new, donated blood through thin tubes into a vessel - through her belly button – at the same exact time). We had many meetings with the head doctor on how she was doing that day. Was she going to make it or not?

At 30 days, she had gained enough weight and had succeeded at taking a bottle, enough to go home. At home, she struggled daily.

Struggled to eat and keep her food down, cried most of each day with what seemed like pain and starvation. Scott had to leave on deployment. I had to do it on my own. I went into a deep, postpartum depression. My mom had to come help me for two weeks to get myself together. Karli continued to struggle; even with multiple visits to her pediatrician. I would always hear "all babies spit up." And "well, she's continuing to gain weight, so we can't do anything right now except try a different formula." We had tried it all.

She still projectile vomited after every meal. Holding her while walking helped, and there was a path in our carpet of how many times I had circled our house in walking to keep her comfortable. Finally, after seven long months of fighting for her, a different pediatrician was in the office that day; he saw what I had been begging others about for so long. We were admitted with "failure to thrive" and "spastic cerebral palsy." She had an Little brothers are the best NG tube placed, to help with her medicine nutritrition, and we were sent home.

Three months later, we had the g-tube placed. Scott was able to come home from deployment two months early and work from shore to help be a support to Karli and me. After that hospitalization, she would have multiple additional admits for pneumonia and respiratory distress – up to four times in one year.

Then came surgeries – two adductor tenotomies (muscle lengthening – near the groin), adenotonsillectomy, and more respiratory distress admits. Many times we were asked to sign a Do Not Resuscitate (DNR) order because they did not think she would make it. But she did. She has pulled through, every time. Her strength and faith is strong.

We have had Edmarc in our lives for four years. They have helped us by assessing her when she is sick -- do we go to the Emergency

They have helped us unite with other families going through similar situations. Karli has Spastic Quadriplegic Cerebral Palsy, Microcephaly, Seizure Disorder, Asthma, Development Delay, Cortical Vision Impairment, very little head control and has a G-Tube. All of this could have been prevented had the nurse back in Triage called the doctor right away instead of waiting.

Today we have a second child, our son Kasey, who is two and a half years old. I had a very good pregnancy with him and a very good, planned C-section. He has no medical issues. Karli has gone 2.5 years without a hospital admit for any illness. We have had colds, but we have been able to control them at home, with Edmarc's help or with her regular pediatrician. We are amazed at how well she has been doing. She is now learning to communicate

with her eyes and sometimes with a Switch communication device. She smiles more now, naturally, than just with a seizure (AMAZING!). She is the most loving, patient person we know. She is beautiful in every way. Perfect to us.

Edmarc would like to discharge us because of how well she has been doing, but we are afraid that the second they do, she will get sick (as this has happened many times before when they have mentioned the "D" word). Scott is deployed, again. When he returns from deployment, next year sometime, our hope is that she will still be able to be discharged from Edmarc's services. We can always be readmitted should we need them. And they will always be there with a listening ear or a shoulder to cry on.

Edmarc Social Workers Present at The 7th Annual Virginia State Genetics Education Conference

On May 20th, the social work staff at Edmarc had an opportunity to present at The 7th Annual Virginia State Genetics Education Conference. The conference was held at Fort Magruder Hotel and Conference Center in Williamsburg, Virginia.

The focus of the conference was on providing a venue for Virginia genetic counselors and other associated professionals to discuss current issues and topics in genetics, to learn about the variety of state programs and available resources and to form a better network of communication.

Participants were able to develop awareness of perinatal hospice programs in Virginia and recognize benefits of this service in the prenatal practice.

The social workers presented on the history and origins of

perinatal hospice and palliative care and statewide perintal hospice programs. They also identified core components of a perinatal hospice program, the emotional impact of a life-threatening prenatal diagnosis on families, and ways to support families through the model of perinatal hospice and palliative care.

Additionally, the conference material enables participants to identify appropriate and supportive ways to present perinatal hospice to parents.

The conference offered a great opportunity to educate professionals on perinatal hospice and programs in Virginia. Our thanks to the Virginia Association of Genetics Counselors for this opportunity.

A HAND REACHING OUT IN THE DARK: MILAN'S STORY by Yolanda, Milan's Mom

Every year for the past five years, my husband and I have hosted a Family and Friends weekend. This became a tradition to celebrate and share the joys of each other's lives, with lots of laughter, fun and plenty of food.

But, in June of 2011, our lives changed when we were faced with a life or death decision. I was pregnant. At 20 weeks gestation, our daughter, Milan, was diagnosed with Trisomy 18, a chromosome defect that affects one in 5,000 women. Many fetuses do not survive to term; others do not see their first birthday.

Upon confimation, we were given the option of termination. Milan's heart had a large hole; ultrasound showed brain tumors and deformities of her hands and feet.

Milan Amanda Myrick was delivered by C-section on November 2, 2011 at Norfolk General Hospital with a team of physicians standing by. Although this decision directly compromised my well being, all possibilities had been thoroughly considered. All went well. Milan would remain in CHKD for the next four months. We credit the grace and favor of the Lord for taking us through that difficult time.

Mercy swaddled Milan through open heart surgery the following January. When all options had been applied and she was discharged, we received a brochure describing Edmarc's services.

Edmarc became a hand reaching out in the dark, with immeasurable support in home visits, the support of the nurses and social workers, loving care through the holidays and so much more. And this year, our Family and Friends weekend took on a charitable component that helped us raise \$1,500 in support of Edmarc and all it does.

Currently, 242 families are being served with Edmarc's extraordinary care. You, too, can support their mission by becoming a sponsor, supporting Edmarc fundraisers, or becoming an Edmarc volunteer. SUNDAY FUN AT MOOSE LODGE #39 IN SUPPORT OF EDMARC






